COMPANY UPDATE – AUCTION RESULTS AND DEBT POSITION

STRONG YEAR END PEARL TRADING RESULT FOR ATLAS

Atlas Pearls and Perfumes Ltd (ASX: ATP) (“Atlas”) successfully completed its 17th and biggest Pearl Auction to date on 14-15 June in Kobe, Japan with sales over A\$4 million at current exchange rates.

“Prices are stable, the auction was well attended and confirmed the exceptional results achieved at our April Auction” said Tim Jones, Atlas Distribution and Sales Manager. “This is a very positive outcome given a busy June calendar for pearl traders and allows the company to finish the year with another record Auction value” he added.

Atlas will hold its next auction in October 2016.

CBA BANK DEBT

The company is pleased to announce it has agreed on all material terms with the Commonwealth Bank of Australia for an extension of its current Debt Facility through to 30 June 2017. Both parties will now proceed to execution of documentation, and a further market update provided in due course.

In accordance with the previous arrangement, the Company will have repaid A\$1 million in core debt by the end of the 15/16 financial year, and the facility will be reduced from A\$5 million to A\$4 million.
